Lower Elkhorn Basin Levee Setback Project
Request to Initiate Project Review Pursuant to Title 33, USC Section 408

<u>1.0 – ITEM</u>

Consider Central Valley Flood Protection Board (Board) approval of a letter (Attachment A) to the U.S. Army Corps of Engineers (USACE) pursuant to federal Title 33, USC Section 408 requesting initiation of, in cooperation with the California Department of Water Resources (DWR) and other federal agencies, a joint review of possible setback levees in the Lower Elkhorn Basin.

2.0 - PROJECT PROPONENT

California Department of Water Resources (DWR)

3.0 - PROJECT LOCATION

The Lower Elkhorn Basin Levee Setback Project includes the east levee of the Yolo Bypass from Interstate 5 to the Sacramento Bypass, and the north levee of the Sacramento Bypass (Attachment B) in Yolo County.

4.0 - PROJECT DESCRIPTION

The purpose of this project is to reduce flood risk by increasing the capacity of the Yolo and Sacramento Bypasses. DWR is proposing to setback the 1.7 mile long north levee of the Sacramento Bypass, and up to six (6) miles of the east levee of the Yolo Bypass adjacent to the Lower Elkhorn Basin. Proposed work may include construction of new levees, partial and full degrade of existing levees, landside fill, installation of cutoff walls and seepage berms, installation of relief wells, modifications to impacted infrastructure (e.g. pumping plants, roads, and utilities), and/or construction of a landside toe access road. The alterations are also being considered under the American River Common Features Project and the Sacramento River GRR. The Board, on behalf of the State of California, anticipates seeking credit for the proposed under Section 221 of the Flood Control Act of 1970. Approval under Section 404 of the Clean Water Act is anticipated

to be required for the proposed work. The proposed project will require lands owned by the non-Federal sponsor, and will not require any lands owned by the USACE.

Pursuant to Title 33, USC Section 408 (Section 408) as described by the U. S. Army Corps of Engineers (USACE) Engineering Circular 1165-2-216, §7c(2), the California Department of Water Resources (DWR) has requested the Central Valley Flood Protection Board (Board) staff to initiate the Section 408 process for the joint review of a possible levee setback project, the Lower Elkhorn Basin Levee Setback Project (hereafter referred to as the LEBLS Project) to setback the 1.7 mile long north levee of the Sacramento Bypass and up to six (6) miles of the east levee of the Yolo Bypass adjacent to the Lower Elkhorn Basin. The purpose of this project is to reduce flood risk by increasing the capacity of the Yolo and Sacramento Bypasses.

Proposed work may include construction of new levees, partial and full degrade of existing levees, landside fill, installation of cutoff walls and seepage berms, installation of relief wells, modifications to impacted infrastructure (e.g. pumping plants, roads, and utilities), and/or construction of a landside toe access road. The alterations are also being considered under the American River Common Features Project and the Sacramento River GRR. The Board, on behalf of the State of California, anticipates seeking credit for the proposed under Section 221 of the Flood Control Act of 1970. Approval under Section 404 of the Clean Water Act is also anticipated to be required for these proposed alterations.

The proposed project will require lands owned by the non-Federal sponsor, and will not require any lands owned by the USACE.

On behalf of DWR, the Board requests the USACE, in cooperation with DWR and other federal agencies, to initiate a joint review of possible alterations for the LEBLS Project. The Board, on behalf of DWR, will seek approval from the USACE to make necessary alterations to the levee system to achieve the project purpose.
