PURPOSE AND AGENDA OF THE SITE VISIT:

The Central Valley Flood Protection Board has arranged a visit to several key parts of the San Joaquin River Restoration Project (SJRRP). The Board plans to view the SJRRP proposed modifications at Reach 4B river channel, Eastside and Mariposa Bypasses, Sand Slough Control Structure, and Reach 2B features including the river channel, Chowchilla Bifurcation Structure (San Joaquin River and Chowchilla Bypass), and Mendota Dam and Pool. They will hear brief presentations by representatives from the U.S. Bureau of Reclamation, Lower San Joaquin Levee District, and the California Department of Water Resources.

Transportation and lunch will be arranged only for Board and Board staff. Staff planning to carpool will be leaving at 7:00 AM from the Joint Operations Center at 3310 El Camino Avenue, Sacramento, California, 95821. Members of the public planning to participate will provide their own transportation, and may join us at the various stops for informational discussions. Please wear appropriate attire, and plan to arrange for your own lunch, sun protection and water.


