**Coming from the North (Modesto) on Highway 99:** In Turlock, take the Lander Ave/Highway 165 exit toward Los Banos. Travel south on Hwy 165 through the communities of Hilmar and Stevinson. At the 4-way stop at the intersection of Hwy 165 and Hwy 140, continue southbound (straight) toward Los Banos for 12.5 miles. Turn left on Wolfsen Road. Follow Wolfsen Road approximately 2 miles until the pavement ends at the Refuge entrance. Continue through the gate on the gravel road -- the Visitor Center parking lot is on the left after passing through main entrance (left turn at the stop sign).

**Coming from the South (Fresno) on Highway 99:** Travel on Highway 99 north to Highway 152 westbound. Travel westbound on Hwy 152 to Los Banos. Turn right on Mercey Springs Road (fourth stoplight after entering Los Banos from the east). Continue on Mercey Springs Road (also called Hwy 165) for approximately 6.5 miles to Wolfsen Road. Turn right onto Wolfsen Road. Follow Wolfsen Road approximately 2 miles until the pavement ends at the Refuge entrance. Continue through the gate on the gravel road -- the Visitor Center is on the left after passing through main entrance (left turn at the stop sign).

**From Interstate 5 (north or south):** Take the Los Banos/Highway 152 east exit. Travel on Highway 152 eastbound into Los Banos. Turn left on Mercey Springs Road. Continue on Mercey Springs Road (also called Hwy 165) for approximately 6.5 miles to Wolfsen Road. Turn right onto Wolfsen Road. Follow Wolfsen Road approximately 2 miles until the pavement ends at the Refuge entrance. Continue through the gate on the gravel road -- the Visitor Center is on the left after passing through the main entrance (left turn at the stop sign).
