## **TOUR SUMMARY**

On Friday, October 12, 2018, the Central Valley Flood Protection Board will conduct a site visit of several facilities, including: West Sacramento Southport Levee Improvement Project, Dos Rios/Three Amigos Project, and Mossdale Basin near Lathrop, which will include a briefing on the Brookside – Delta Front project.

The purpose of the tour is to view and gain a better understanding of:

- A levee improvement project that is part of a larger South Basin Plan that, once completed, will provide a 200-year level of flood protection to the southern portion of West Sacramento, reduce annual flood damage to the area, and provide ecosystem and habitat restoration.
- Multi-benefit flood management/habitat restoration projects consisting of 3,400 acres in the San Joaquin River primary floodplain which will be managed as perpetual wildlife habitat and/or enrolled in flowage easements. These multi-benefit projects comprise the largest contiguous riparian habitat restoration effort in California, and help reconnect the San Joaquin River with its natural floodplain.
- Two sites that highlight high priority flood and storm damage risk management issues in the San Joaquin Valley containing vulnerable and exposed small communities and infrastructure.
