Ongoing Operations

- On June 12, Board President Edgar, Board Member Macdonald and EO Gallagher attended a water portfolio recommendations group to discuss the Governor's Water Resiliency Portfolio. The group consisted of NGO, tribal and local interests as well as the managers of some water agencies, DWR, the Water Board and others.
 Nancy Vogel is the appointee in charge of delivering the recommendations to the Governor. The Board has scheduled a listening session in June and July Board

meetings to obtain stakeholder input and staff will be developing a list of recommendations and examples of how the flood community is already implementing many of the resiliency strategies.

 On June 14, 2019 the Board held a workshop in West Sacramento. Topics discussed were the Operations and Maintenance update of the U.S. Army Corps of Engineers, the Department of Water Resources, and the Central Valley Flood Protection Board.
