The City made revisions to the project and/or incorporated mandatory mitigation measures into the project plans to avoid impacts or to mitigate such impacts to a point where no significant adverse impacts will occur. These mitigation measures are included in the City Is/MND and address impacts to biological resources, cultural resources, geology and soils, hydrology and water quality, and noise. The mitigation measures are further described in the City's adopted Is/MND. In accordance with CEQA Guidelines Section 15096(e), Board staff independently reviewed the City's Is/MND, and finds these environmental documents prepared by the lead agency adequately address hydrology impacts, including potential flood risk, within the Board's jurisdiction. The Board, as a responsible agency, is responsible for mitigating and avoiding only the direct and indirect environmental effects of those parts of the project which it decides to carry out, finance, or approve (CEQA Guidelines § 15096(g); Public Resources Code § 21002.1(d)). In accordance with CEQA Guidelines Section 15096(f) and (g), staff recommends the Board make responsible agency findings that approval of Permit No. 19365 would not have a significant adverse impact and no additional mitigation measures within the Board's jurisdiction are required.
