These documents, including project design are available for review in hard copy at the Board and City of Madera offices. The City of Madera determined the project would not have a significant effect on the environment and filed a Notice of Determination on November 17, 2011 with the Madera County Clerk-Recorder. Board staff finds that although the proposed project could have a potentially significant effect on the environment, there will not be a significant effect in this case because revisions in the project have been made by or agreed to by the project proponent. The project proponent has incorporated mandatory mitigation measures into the project plans to avoid identified impacts or to mitigate such impacts to a point where no significant impacts will occur. These mitigation measures are included in the project proponent's IS/MND and address impacts to aesthetics, air quality, cultural resources, hydrology. The description of the mitigation measures are further described in the adopted IS/MND.
