1513-1	Pacific Gas & Electric Company (PG&E)	The 110 kV transmission line goes across the American River and its levees at a point north of PG&E's Brighton Substation, then follows the existing PG&E transmission lines to a point on the northerly side of the USBR's 230kV transmission line right of way, and then pralleling the said 230 kV transmission line generally through the overflow area of the American River Floodway to a point north of the American River opposite SMUD's Substation at 21st and North C Streets in Sacramento, then across the American River and its south levee at a point north of the 21st and North C Street Substation to deliver power to the substation.	Sacramento	American River	This is a "name change" permit only and includes conditions that are consistent with current flood control standards and policies of the Central Valley Flood Protection Board. This permit supplements Permit No. 1513 that was issued to Sacramento Municipal Utility District (SMUD) on November 1, 1950, via Board Order, for the construction of a 110 kV electric power transmission line in the American River floodway and extending westerly for a distance of about four miles from a point about one-half mile upstream from the "H" Street Bridge to deliver power from the PG&E Brighton Sub-station to the SMUD Sub-station. To place rock slope protection along 140 feet of the left (east) bank of the Sacramento River.</p> <p>This permit also facilitates a name change to Permit No. 16872 that was issued to Mr. Sean Gotts on September 22, 1998 to construct a 36-by-36-foot private residence, 4-foot-wide access walkway, 10-foot-wide ramp, and a 30-by-30-foot floating dock on the left bank of the Sacramento River.</p>	Reclamation District 1000	<p>Board staff has determined the project is exempt from CEQA under the Class 1, Existing Facilities and Class 4, Minor Alterations to Land categorical exemptions (CEQA Guidelines § 15301 and § 15304, respectively), because the activity consists of permitting an existing 6-foot tall fence and a 16-foot wide gate on the waterside levee slope, 10-feet from the Garden Highway edge of pavement, and authorizing the placement of rock slope protection along 140 feet of the left (east) bank of the Sacramento River. Further, none of the exceptions to the exemption in CEQA Guidelines § 15300.2 apply.</p> <p>In addition, this permit would facilitate a name change. An application to change the name of the permittee does not have the potential to result in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment, and thus, is not a "project" for purposes of the California Environmental Quality Act (Public Resources Code § 21065; CEQA Guidelines § 15378(a)).</p>

Colusa	Colusa Basin Drain	To remove and replace an existing 48-inch diameter steel pipe with a new 48-inch diameter welded steel pipe, and to install a 60-inch diameter steel vertical riser with a canal gate, all through the east levee of the Colusa Drain.	N/A	Board staff has determined the project is exempt from CEQA under the Class 2, Replacement or Reconstruction categorical exemption (CEQA Guidelines § 15302), because the proposed activity consists of the removal and replacement of an existing 48-inch diameter pipe with a new 48-inch diameter pipe, having the same purpose and capacity. In addition, the proposed project will be salvaging and reusing an existing flap gate and canal gate on the west and east ends of the new pipe. Further, none of the exceptions to the exemption in CEQA Guidelines § 15300.2 apply.

N/A	Board staff has determined the project is exempt from CEQA under the Class 1, Existing Facilities categorical exemption (CEQA Guidelines § 15301), because the activity involves the permitting of existing Bridge No. 12-0122 (constructed prior to 1962). Further, none of the exceptions to the exemption in CEQA Guidelines § 15300.2 apply.
2433-1	Michael Leschinski	The project is located at 3791 Garden Highway approximately 0.1 mile north of Radio Road	Sacramento	Sacramento River	To construct a second story addition, above an existing detached garage, with an open deck and a set of exterior stairs located on the left (east) bank of the Sacramento River.	Reclamation District 1000	Board staff has determined the project is exempt from CEQA under the Class 3, New Construction and Conversion of Small Structures categorical exemption (CEQA Guidelines § 15303), because the proposed activity consists of the construction of an addition to an existing dwelling. Further, none of the exceptions to the exemption in CEQA Guidelines § 15300.2 apply.
