Consider approval of Permit Nos. 19495-1 and 19496-1, To construct five (5) oil production wells, related pipelines, and appurtenances on the right (north) bank of the Kern River Designated Floodway, Kern County APN 436-052-22, under Permit No. 19495-1; and to construct eight (8) oil production wells, related pipelines, and appurtenances on the left (south) bank of the Kern River Designated Floodway, Kern County APN 436-052-23, under Permit No. 19496-1, respectively. The projects are located along China Grade Loop, approximately 0.4 miles south west of the intersection of China Grade Loop and Round Mountain Road, north east of the City of Bakersfield (Kern County).

B. <u>Permit No. 19552 Sanchez-Hoggan Annexation Project</u> (Nate Kibret, Operations Branch, Board Staff)

Consider approval of Permit No. 19552 to install two (2) 18-inch diameter storm drain pipes, approximately 14 feet from the top bank, and outfall structure; installation of a 48-inch diameter storm drain pipe crossing approximately 10 feet below the channel; installation of two (2) 4 feet by 10 feet box culverts at the east entrance from Austin Road; modification of an existing box culvert, and associated channel widening along Austin Road; and removal of two (2) dilapidated farm road crossings and placing riprap along the banks of North Little Johns Creek - South Branch, also known as Weber Slough. The project is located approximately 2 miles east of the intersection of CA Highway 99 and Arch Road, southeast of the City of Stockton (San Joaquin County).

C. <u>Permit No. 19470 Turlock Irrigation District</u> (Jacqueline Hoang, Operations Branch, Board Staff)

Consider approval of Permit No. 19470 to construct a fish barrier on the right (east) bank of the San Joaquin River. The barrier will be a metal screen with removable panel sections and a reinforced concrete foundation. The project is located 500 feet west from the intersection of West Harding Road and South Carpenter Road, at the Harding Drain Culvert for the Turlock Irrigation District, east from Patterson. (Stanislaus County)

The Project includes seepage berms, cutoff walls, and the construction of a 1,120-foot setback levee. The Project is located on the right (east) bank of the San Joaquin River south of Stockton in San Joaquin County
