A. <u>Permit No. 19445-2, City of Sacramento – Water Forum</u> (*Nate Kibret, Operations Branch, Board Staff*)

Consider approval of Permit No. 19445-2 to implement the Lower American River Anadromous Fish Habitat Restoration Project. The complete implementation of the proposed work would require removing approximately 3,309 CY of material and placing approximately 7,110 CY of material. The project is located on the right (north) bank of the Lower America River, approximately 0.15 miles downstream of Nimbus Dam. (Sacramento County).

B. <u>Permit No. 19445-3, City of Sacramento – Water Forum</u> (Nate Kibret, Operations Branch, Board Staff)

Consider approval of Permit No. 19445-3 to implement the Lower American River Anadromous Fish Habitat Restoration Project. The complete implementation of the proposed work would require removing approximately 24,695 CY of material and placing approximately 37,624 CY of material. The project is located on the left (south) bank of the Lower America River, approximately 0.9 miles upstream of the Sunrise Boulevard Bridge, in the area commonly known as Lower Sailor Bar. (Sacramento County).

C. Permit No. 19624 City of Woodland (Deb Biswas, Operations Branch, Board Staff)

Consider approval of Permit No. 19624 to remove two existing 48-inch diameter culverts and abandon a third existing 48-inch diameter culvert by fully grouting it in place and replace them with a single cast-in-place concrete box culvert of approximately 115 feet long, 31 feet wide, and 8 feet tall with four 6-foot by 6-foot bays. The project will also include the construction of cast-in-place concrete headwalls located at the inlet and outlet structures equipped with waterside flap gates and a positive closure device at the waterside levee crown. The proposed project is located 0.3 miles north of Interstate 5 and 4.3 miles east of State Route 113, on Unit 3, Yolo Bypass West levee at Levee Mile 1.46. (Yolo County)

Consider approval of Permit No. 19624 to remove the two existing 48-inch diameter culverts and abandon the third existing 48-inch diameter culvert by fully grouting it in place and replace them with a single cast-in-place concrete box culvert of approximately 115 feet long, 31 feet wide, and 8 feet tall with four 6-foot by 6-foot bays. The project will also include the construction of cast-in-place concrete headwalls located at the inlet and outlet structures equipped with waterside flap gates and a

California Central Valley Flood Protection Board Meeting, June 24, 2022 positive closure device at the waterside levee crown. The proposed project is located 0.3 miles north of Interstate 5 and 4.3 miles east of State Route 113, on Unit 3, Yolo Bypass West levee at Levee Mile 1.46. (Yolo County)

D. <u>Permit No. 19645 UPRR Bridge Replacement</u> (Humberto Negrete, Operations Branch, Board Staff)

Consider approval of Permit No. 19645 to replace the existing nine-span, 120-footlong timber stringer single-track railroad bridge spanning Mosher Slough with a fivespan, 150-foot-long prestressed concrete box bridge on driven steel H-Pile bents and abutments. Erosion control riprap will be placed at the abutments. A construction pad will be utilized in the floodway for the work activities. The bridge is located at Milepost 78.9 on the UPRR Fresno Subdivision, where it spans Mosher Slough, approximately 0.75 mile southwest of the intersection of Morada Lane and Holman Road in the City of Stockton. (San Joaquin County)

E. <u>Permit No. 19646 UPRR Bridge Replacement</u> (Humberto Negrete, Operations Branch, Board Staff)

Consider approval of Permit No. 19646 to replace the existing six span, 85-foot-long timber-stringer-trestle (TST) single track bridge that crosses a segment of the Cross Creek Designated Floodway with a three span, 108-foot-long precast concrete box (PCB) girder bridge on driven H-pile bents with concrete bent caps. Riprap will be placed at the abutments for erosion control. The project is located where the existing UPRR Fresno Subdivision rail line crosses Cross Creek at Milepost (MP) 235.13, approximately 10 miles northwest of the community of Visalia. (Tulare County)

F. <u>Permit No. 19648 City of Stockton - Mormon Slough Bridge No. 29C0238 Repairs</u> (Jacqueline Hoang, Operations Branch, Board Staff)

Consider approval of Permit No. 19648 to authorize the existing Mormon Slough Bridge No. 29C0238, which was constructed in 1960. The project also includes reconstruction of the bridge foundation by installing concreted-rock slope protection on both abutments and piers of the bridge within the Mormon Slough floodway, reconstructing bridge approach roadways, installing concrete barriers, placing methacrylate treatment on the bridge deck to seal cracks, and constructing a drainage ditch on the northeast corner of the bridge at Abutment 6. The project is located about 970 feet southeast of the intersection between E. Anderson Street and Diamond Street in the City of Stockton, at 37.94581°N 121.25604°W, Mormon Slough. (San Joaquin County).

G. <u>San Joaquin River East Levee System - Letter of Intent</u> (Eric Miao, Operations Branch, Board Staff)

Consider authorizing the Executive Officer to transmit a Letter of Intent to develop and implement a System-Wide Improvement Framework to the USACE, prepared by Reclamation District (RD) 17 for the San Joaquin River East Levee System as defined by the USACE's Routine Inspection Report dated December 18, 2020. The LMAs in this system include: RD 17, RD 2094, RD 2096, RD 2075, and RD 2064 (San Joaquin County).

Informational briefing on the 2022 Supplemental Environmental Impact Statement/Environmental Impact Report for the Folsom Dam Raise Modifications Project, which consists of the improvements to several features along the southern and western sides of Folsom Lake, including construction of a new Dike 3, construction of concrete floodwall raises on Dike 1, Dikes 4-7, and the Mormon Island Auxiliary Dam (MIAD), onsite borrow and disposal at MIAD West, rock crushing operations at MIAD East, disclosure of a comprehensive mitigation plan, and smaller scale actions to reduce flood risk to the Sacramento area.

Informational briefing on future Board actions to transfer operation and maintenance (O&M) responsibilities of erosion protection work to the local maintaining agencies as part of the Sacramento River Bank Protection Project and to transfer O&M responsibilities of the Phase 2A North and Phase 2A South segments of levee fortified with a new cutoff wall to the Marysville Levee District.

F. <u>City of Woodland Flood Risk Reduction Project Design Agreement and Local Design</u> <u>Agreement, Lower Cache Creek, Yolo County</u> (*Mike Zelazo, Plan Implementation and Compliance Branch, Board Staff and Vance Cave, Flood Projects Office, Department of Water Resources*) (Informational)

The U.S. Army Corps of Engineers (USACE) plans to design the improvement of existing levees and a new levee north of the City of Woodland in order to prevent floodwaters emanating from Lower Cache Creek from reaching the built-up portion of the City of Woodland. The proposed project features include new levee embankment, seepage berms, a drainage channel, a detention basin, cutoff walls, a weir into the Cache Creek Settling Basin, closure structures across roads and railways, and a managed overtopping section. The Project has received Work Plan Funding from the USACE for Preliminary Engineering Design. To receive this federal funding to advance the Project, a Design Agreement and the Local Design Agreement will be required.
