A. Permit No. 19173 Brannan-Andrus Levee Maintenance District (*Humberto Negrete, Operations Branch, Board Staff*)

Consider approval of Permit No. 19173 to place rock-fill and erosion protection, enhanced with vegetated benches and slopes, at three sites, totaling approximately 7,200 linear feet, along the left (south) bank levee of the Sacramento River. Wetland bench to consist of soil and rock fill placed at approximately 1 foot above Mean Low Water and will be supported by a rock-fill base. Riparian bench to consist of 4-ft tall retaining wall with soil and rock fill placed at approximately 5 feet above Mean Low Water. Vegetated slope consisting of soil and rock to continue to waterside levee hinge. The project is located along the Brannan-Andrus Tract at three sites located between the community of Isleton and 2.5 miles west along State Route 160. (Sacramento County)

B. Permit No. 19664 City of Chico (*Deb Biswas, Operations Branch, Board Staff*)

Consider approval of Permit No. 19664 to install a single concrete outfall structure into the Little Chico Creek. The outfall will conform to the City of Chico's Improvement Standards and include a concrete outfall with a 30-inch diameter pipe with flap gate and a cutoff headwall with sloping sides to conform with the existing banks of Little Chico Creek. The headwall will be 4 feet 10 inches wide and 4.5 feet deep. A manually operated slide gate / butterfly valve / or other approved positive closure will be housed in the manhole near the outfall. The project is located 0.41 miles south of State Route 32 and 0.42 miles west of Bruce Road in Chico. (Butte County)

C. Cache Creek – Yolo Bypass – Knights Landing Levee System - Letter of Intent (*Eric Miao, Operations Branch, Board Staff*)

Consider authorizing the Executive Officer to transmit a Letter of Intent to develop and implement a System-Wide Improvement Framework to the USACE, prepared by Knights Landing Ridge Drainage District for the Cache Creek – Yolo Bypass – Knights Landing Levee System as defined by the USACE's Periodic Inspection Report dated May 1, 2013.

D. Ash Slough Right Bank, Ash Slough Left Bank – Berenda Slough Right Bank, and Berenda Slough Left Bank – Fresno River Right Bank, and Fresno River Left Bank Levee Systems - Letter of Intent (*Eric Miao, Operations Branch, Board Staff*)

Consider authorizing the Executive Officer to transmit a Letter of Intent to develop and implement a System-Wide Improvement Framework to the USACE, prepared by

Madera County for the Madera County River East Levee System as defined by the USACE's Periodic Inspection Report dated September 25, 2014.

E. Sacramento River Bank Protection Project, Transfer of Operation and Maintenance Responsibilities, Sacramento County (*Mike Zelazo, Flood System Improvement Branch, Board Staff*)

Consider approval of Board Resolution 2022-11 that transfers operation and maintenance responsibilities of completed erosion protection and revegetation work along the Sacramento River East Levee at River Miles 47.0, 49.6, 49.7, 49.9, 50.4, 50.8, 52.3, 52.4, and 53.1 to Reclamation District 744 and delegate the Executive Officer to sign and send a letter informing the District of the transfer.

F. Sacramento River Bank Protection Project, Transfer of Operation and Maintenance Responsibilities, Sacramento and Sutter Counties (*Mike Zelazo, Flood System Improvement Branch, Board Staff*)

Consider approval of Board Resolution 2022-12 that transfers operation and maintenance responsibilities of completed erosion protection and revegetation work along the Sacramento River East Levee at River Miles 68.9, 73.5, and 78.0 to Reclamation District 1000 and delegate the Executive Officer to sign and send a letter informing the District of the transfer.

G. Sacramento River Bank Protection Project, Transfer of Operation and Maintenance Responsibilities, Sutter County (*Mike Zelazo, Flood System Improvement Branch, Board Staff*)

Consider approval of Board Resolution 2022-13 that transfers operation and maintenance responsibilities of completed erosion protection and revegetation work along the Sacramento River East Levee at River Miles 87.0 and 93.7 to Reclamation District 1500 and delegate the Executive Officer to sign and send a letter informing the District of the transfer.
