Approve Permit No. 19640 to drive steel piles and place concrete anchor blocks in the Sacramento River and Georgiana Slough to install a Bio-Acoustic Fish Fence (BAFF) as part of the Georgiana Slough Salmonid Migratory Barrier Project. Project activities include creating a staging area with temporary security fencing, exclusion fencing, and a service pole, removing two dolphin structures, installing monitoring and data collection equipment such as hydrophones, and installing navigational aids (floating buoys/signs). The BAFF barrier components will be constructed, operated, and removed periodically through 2030. The BAFF piles and other supporting infrastructure will remain in place until project completion by November 1st, 2030. The proposed project is located at the confluence of the Georgiana Slough and Sacramento River approximately 406 feet west of the intersection of Depot Lane and Shop Street in Sacramento County, CA (Sacramento County).

 - Informational briefing for a future Board action to transfer operation and maintenance responsibilities, supplement to Standard O&M Manual, Unit 118 Part 2, to American River Flood Control District for levee improvement work completed by Sacramento Area Flood Control Agency under a 408 Letter of Permission (Encroachment Permit No 19055). The construction was completed in 2019, and included a slurry cutoff wall, relief wells, and drain trench along the Arcade Creek north and south levees, Natomas East Main Drainage Canal East levees.
- D. <u>Middle-Mile Broadband Network (MMBN)</u> (Steve Lamb, Operations Branch, Board Staff; Hardeep Takhar, MMBN Program Director and / or Janice Benton, Assistant Deputy Director, Middle-Mile Broadband Initiative; a representative from Caltrans North Region districts) (Informational)
 - Caltrans will be proposing to Install (3)-2" HDPE conduits, fiber optic cable, vaults and network hub shelters along 10,000 miles of State Highway Right of Way, to provide a statewide open-access middle-mile network to serve unserved and underserved communities as outlined in California Senate Bill 156. Underground installation is at a depth of 24" to 42" and construction methods include trenching, horizontal boring, trench in pavement and plowing. Aboveground installation includes attachment of (1)-5" conduit or (3)-2" conduits to bridges. This project will encroach within the Central
