1. WELCOME, INTRODUCTIONS AND ANNOUNCEMENTS

Mr. Bill Edgar, Board President, welcomed the participants.

Ms. Leslie Gallagher, Board Executive Officer, announced that Ms. Andrea Buckley has been officially hired as the Board Environmental Sciences and Land Management Branch Chief.

In addition, Mr. Aaron Harris was hired as a Board Senior Support Analyst; and Ms. Monica Reis and Mr. Preston Shopbell as Board Senior Engineers.

Ms. Kathryn Baines, Board Analyst, called the roll and a quorum was achieved, with six members present.

3. APPROVAL OF MINUTES – July 22, 2016 Board Meeting

4. REVIEW OF AGENDA

Executive Officer Gallagher announced that USACE approval letters have been received for Consent Items 5C and 5D. Also, there will be a Closed Session today (Item 9A).

Upon **motion** by Board Member Countryman, seconded by Board Member Macdonald, the Board unanimously approved the Agenda.

5. CONSENT ITEMS

A. Cease and Desist Order issued to Mr. J.W. Sutton

Consider the Cease and Desist Order for Enforcement Action No. 2016-5838 issued to Mr. J.W. Sutton. The Cease and Desist Order establishes Mr. Sutton as a responsible party for damage to a State Plan of Flood Control levee that was subsequently repaired by the Department of Water Resources and directs the responsible party to complete any additional corrective actions upon further direction of the Central Valley Flood Protection Board. The levee at issue is located within Sacramento-San Joaquin Drainage District flood protection easements in the Sutter Bypass, approximately 0.6 miles north of the Obanion Road and the Sutter Bypass East Levee crown road intersection. At the meeting, the Board may affirm, amend, modify, stay, or rescind the Cease and Desist Order. (Sutter County)

B. Cease and Desist Order issued to Mr. Glenn Marler

Consider the Cease and Desist Order for Enforcement Action No. 2016-5838 issued to Mr. Glenn Marler. The Cease and Desist Order establishes Mr. Marler as a responsible party for damage to a State Plan of Flood Control levee that was subsequently repaired by the Department of Water Resources and directs the responsible party to complete any additional corrective actions upon further direction of the Central Valley Flood Protection Board. The levee at issue is located within Sacramento-San Joaquin Drainage District flood protection easements in the Sutter Bypass, approximately 0.6 miles north of the Obanion Road and the Sutter Bypass East Levee crown road intersection. At the meeting, the Board may affirm, amend, modify, stay, or rescind the Cease and Desist Order. (Sutter County)

C. Permit No. 19094, Union Pacific Railroad

Consider approval of Permit No. 19094 to replace an existing bridge spanning the Consumes River west of Highway 99 and north of Dillard Road in unincorporated Sacramento County. (Sacramento County)

D. Permit No. 19095, Union Pacific Railroad

Consider approval of Permit No. 19095 to replace an existing bridge spanning the Consumes River located west of Highway 99 and south of Dillard Road in unincorporated Sacramento County. (Sacramento County)

Upon motion by Board Member Macdonald, seconded by Vice President Suarez, the Board approved the Consent Calendar (6-0-1 absent).

This motion was subsequently amended (see Public Comments below, Item 6):

Upon motion by Vice President Suarez, seconded by Board Member Villines, the Board authorized staff to proceed with the beginning of enforcement processes for
