## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION American River Common Features 2016 Project Sacramento River, Reach D, Contract 1 Front Street Stability Berm

The U.S. Army Corps of Engineers (USACE), Sacramento District and the Central Valley Flood Protection Board (CVFPB) have prepared a Draft Supplemental Environmental Assessment / Initial Study / Mitigated Negative Declaration (SEA/IS/MND) for the American River Common Features (ARCF) 2016 Project, Sacramento River, Reach D, Contract 1 (RDC1) Front Street Stability Berm Project (Proposed Project). The document supplements the ARCF 2016 General Reevaluation Report Final Environmental Impact Statement / Environmental Impact Report (State Clearinghouse # 2005072046). Pursuant to the California Environmental Quality Act (CEQA), the CVFPB (CEQA lead agency) has prepared the document with the intent to adopt the Mitigated Negative Declaration (MND).

The Proposed Project is located adjacent to Front Street, west of Interstate 5, north of U.S. Highway 50, and south of the Tower Bridge in Sacramento, CA. The Proposed Project is a levee improvement consisting of an approximately 400-foot stability berm against the landside slope of the Sacramento River east levee (SREL). Seepage conditions in the project area make this levee segment susceptible to failure during high water events. The purpose of the Proposed Project is to reinforce and reduce seepage through this section of the SREL.
