1. WELCOME, INTRODUCTIONS AND ANNOUNCEMENTS

Mr. Bill Edgar, Board President, welcomed the participants.

2. ROLL CALL/ESTABLISH A QUORUM (Water Code § 8560)

Ms. Kathryn Baines, Board Analyst, called the roll, five members present, and a quorum was established.

3. APPROVAL OF MINUTES – February 23, 2018 - Postponed

4. REVIEW OF AGENDA

President Edgar reviewed the Agenda.

Ms. Leslie Gallagher, Board Executive Officer, mentioned that, as part of the Board/DWR/Stewardship Council Memorandum of Understanding implementation, a Stewardship Council Meeting was held on April 26, 2018 and meeting members did decide to adopt their Delta Levee Investment Strategy as a regulation.

Executive Officer Gallagher also noted that the Board had received the official USACE Letters for Consent Calendar Items A and B; both were signed and contained no additional conditions.

5. BOARD RESOLUTION PRESENTATION

A. The Board will present a resolution honoring former Reclamation Board President and Secretary Jane Carter, who served on the Board from 1983 to 1996 and passed away in March.

President Edgar welcomed and presented the Resolution to Carter Family members Ben Carter and Denise Carter. Board Members and others expressed their appreciation for Ms. Jane Carter and shared remembrances of their interactions with her.

6. CONSENT ITEMS

A. Permit No. 19142 City of Yuba City

Consider approval of Permit No. 19142 to construct a new landside levee access ramp in the southbound direction on the Feather River right (west) bank levee; to install two new pipe gates, a removable bollard on the access ramp, pipe fencing, a 15-foot wide access road; to remove an existing 83-foot long levee toe retaining wall, three Pacific Gas and Electric (PG&E) overhead electric poles, anchors, and lines, and the removal and replacement of 40-foot chain link fence. (Sutter County)

B. Permit No. 19162 Interstate 5 (I-5) Beach Lake Bridge Widening

Consider approval of Permit No. 19162 to widen the existing I-5 bridge (Bridge No. 24-0262) crossing Morrison Creek by closing the separation between the north-bound and south-bound bridges. (Sacramento County)

C. Folsom Dam Raise Supplemental EIS/EIR

Consider approval of Resolution No. 2018-01 to certify the Folsom Dam raise Supplemental Environmental Impact Statement/Environmental Impact Report (SEIS/EIR); adopt the Statement of Findings; adopt the Statement of Overriding Considerations; and adopt the Mitigation Monitoring and Reporting Plan.

D. Marysville Ring Levee Supplemental IS/EA/MND

Consider approval of Resolution No. 2018-02 to adopt the Marysville Ring Levee Improvement Project Supplemental Environmental Assessment/Initial Study/Mitigated Negative Declaration, Mitigation and Monitoring and Reporting Plan, Statement of Findings; and approve the design refinements for Phase 2A South and 2C.

As a follow-up to the April 2017 Project briefing, USACE will brief the Board on the status of the Folsom Dam Raise Project, including the updated design configuration, benefit, cost and schedule. Department of Water Resources project management staff will present an informational update on the path forward for the Project Partnership Agreement (PPA) and Local Project Partnership Agreement (LPPA).
