A. Permit No. 18956-3, High Speed Rail Authority

Consider approval of Permit No. 18956-3 to construct two sets of bridge tracks to support high speed train over the Kings River south of the City of Fresno. (Kings County)

B. Permit No. 19194 Brad Thomas

Consider approval of Permit No. 19194 to construct a new 2,300 square-foot dwelling with 620 square-foot attached garage on the right (north) bank area in Area C of the Yuba River Designated Floodway. (Yuba County)

Mr. Sungho Lee, Board Staff Engineer, presented the staff report and answered questions.

Mr. Gary Lemon, Board Senior Engineer; Mr. Ryan Larson, USACE; and Mr. Kanwarjit Dua, Board General Counsel, responded to Board Member questions and provided clarifying information.

Upon motion by Board Member Countryman, seconded by Board Member Macdonald, the Board approved Item 5B (4-0-3 absent).

C. Permit No. 19206 City of Lathrop

Consider approval of Permit No. 19206 to construct an outfall structure that includes six 36-inch diameter pipes through the right (east) bank levee of the San Joaquin River. (San Joaquin County)

President Edgar was present for this item. Board Member Countryman recused himself from Item 5C.

Mr. Deb Biswas, Board Staff Engineer, gave the presentation. He and General Counsel Dua answered questions.

Mr. Steve Salvatore, Lathrop City Manager; Mr. Chris Ragan, MacKay and Somps; and Ms. Alicia Guerra, Buckhalter, provided additional information and answered questions.

Upon motion by President Edgar, seconded by Board Member Macdonald, the Board approved Permit Number 19206, including Condition 38 as drafted by the staff (4-0-2 absent-1, Countryman – Recused).

Further, upon **motion** by President Edgar, seconded by Board Member Macdonald, the Board directed Board staff to research the issue Board Member Ramirez discussed regarding previous more comprehensive approval of the development in this region (4-0-2 absent-1, Countryman – Recused).

Ms. Patricia Woolery, Hallwood property owner, discussed the time it takes to process permit applications and urged the Board to consider streamlining the process to minimize the timelines involved.

C. State-Federal Flood Operations Center 2017 After-Action Report

Briefing on State-Federal Flood Operations Center (FOC) 2017 After-Action Report, which provides an overview of 2017 storms, FOC response activities, and recommendations for future improvement.
