Army Corps of Engineers (USACE) and the San Joaquin Area Flood Control Agency (SJAFCA), and approval of the Local Design Agreement between the Board and SJAFCA for the San Joaquin River Basin, Lower San Joaquin River California Project.

Mr. Ali Porbaha, Board Senior Engineer, further clarified some of the specifics of the agreement and answered questions.

Mr. Dominick Gulli asked for confirmations on some of the elements of the agreement.

B. Permit Nos. 15565-1, 15863-1, 12827-1, 1559-A-1, 3112-1, 7019-1, 12074-1, 13930-1, 1398-1, 17977-1, 6016-3, 14420-1, 19239, 1119-1, 13657-1, 19240, and 19241, a total of seventeen encroachments along Feather River West Levee Project

Consider approval of the above seventeen permits covering twenty-two individual encroachments for pressurized storm drain pipes, raw water pipes, low pressure gravity irrigation pipe, abandoned pipe, fiber optics cable, and electrical conduit related to the encroachments along 14.8 miles of levees in Project Area C of the Feather River West Levee Project located upstream from Shanghai Bend to north of Campbell Road in the City of Live Oak. C. Permit No. 19120 Esperanza Ross and Brian Flaherty

Consider approval of Permit No. 19120 to construct a new dwelling and boat dock along the left (east) bank of the Sacramento River at 2489 Garden Highway. (Sacramento County)

- A. Permit No. 19233, Smith Canal Gate Project

Consider approval of Permit No. 19233 to construct a fixed dual steel sheet pile floodwall, a steel miter gate structure, seismic stability wall, seepage cutoff wall, single sheet pile floodwall, recreational features and habitat improvements. The project site is located at the confluence of Smith Canal and Atherton Canal, approximately 3.5 miles south of Stockton, extending from the southern bank of Browns Island to the northern tip of Dad's Point. (San Joaquin County)

Mr. Ali Porbaha, Board Senior Engineer, gave the presentation and concluded with the staff recommendation that the Board approve the draft encroachment Permit Number 19233 in substantially the form provided in Attachment A; and that the Board direct the Executive Officer to take the necessary action to execute the permit and to file a Notice of Determination pursuant to CEQA with the State Clearinghouse.

Mr. Chris Elias, SJAFCA Executive Director; Mr. Dan Wright, City of Stockton Vice Mayor; Ms. Kim Floyd, Public Outreach Consultant; Mr. Scott Shapiro, SJAFCA General Counsel; and Mr. Dave Peterson, Peterson Brustad, all spoke in support of permit approval.

Mr. Gulli spoke in opposition to approval.

The Board formally closed the Public Comment portion of the Hearing and deliberated further.
