**1. WELCOME, INTRODUCTIONS AND ANNOUNCEMENTS**

Mr. Bill Edgar, Board President, welcomed the participants.

Ms. Leslie Gallagher, Board Executive Officer, introduced Mr. Darren Suen, recently hired as a Board Policy Advisor. She also congratulated Board staff member Ms. Jenna Peterson, who passed the PE exam and is now a registered civil engineer in the State of California.

**A. Permit No. 19381 Penryn Road Bridge Project**

**Consider approval of Permit No. 19381 to remove an existing culvert and replace the crossing with a single span bridge. The project is located along Penryn Road, approximately 0.25 miles south of the intersection with Interstate 80, near the City of Penryn. (Placer County)**

**B. American River Watershed Common Features (ARCF) 2016 Supplemental Environmental Assessment/Initial Study/Mitigated Negative Declaration**



**Consider adoption of Resolution No. 2019-13 to certify the ARCF Beach-Stone Lakes Mitigation Site Project Supplemental Mitigated Negative Declaration and Supplement to the Mitigation Monitoring and Reporting Plan, and delegate authority to the Executive Officer to execute the Notice of Determination.**

Ms. Lori Price, DWR Environmental Scientist, clarified the issues related to levee vegetation mitigation.

**C. Adopt Amended Board Policy Regarding Board Member Participation on Committees and Liaison Assignments, Updated Governance Principles, and Resolution 2019-12 appointing Jane Dolan Vice President of the Board.**

*Upon motion by Board Member Macdonald, seconded by Board Member Countryman, the Board approved Items 5A and 5C. (6-0-1 vacant)*

Mr. Dominick Gulli, stating he represents *Save Dad's Point*, reported a letter of reconsideration he submitted in response to the recently approved Permit for the Smith Canal Gate Project.

**7. PUBLIC SAFETY INFORMATIONAL**

**A. Informational briefing and public safety discussion of ongoing efforts to address levee system damage from activities in and around homeless encampments**

**Briefing by and discussion with local maintaining agencies currently dealing with the challenges of damage to the levee system caused by human activity in and around existing homeless encampments.**

Mr. Darren Suen, Board Policy Advisor, provided information and introduced the presentation and discussion.

Mr. Kevin King, Reclamation District 1000 General Manager; Mr. Tim Kerr, American River Flood Control District General Manager; Mr. Chris Neudeck, Kjeldsen, Sinnock and Neudeck; Mr. Chris Collins, Sacramento Assistant City Manager; Mr. Dominick Gulli; and Ms. Catherine Freeman, Assembly Water, Parks and Wildlife Committee Consultant (speaking on behalf of Wildlife Committee Chair Eduardo Garcia) presented information and PowerPoint presentations on their concerns of integrity and safety of the State Plan of Flood Control infrastructure. Board Members, along with the presentation and staff had an extensive discussion about the scope of the problem and possible actions to resolve.



Mr. Jit Dua, Board General Counsel, discussed potential legal remedies to address the situation. The Board requested this item be placed future agendas for updates and further discussion.

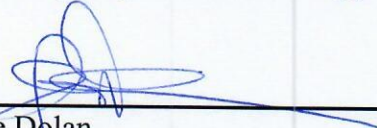

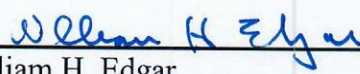
