- B. Permit No. 19486, Reclamation District 817, Bear River Setback Levee Project (*Mike Zelazo, Plan Implementation and Compliance Branch, Board Staff*) (Action Item)

Consider adoption of Resolution 2022-03 to approve Permit No. 19486 for the Bear River Setback Levee Project (Project) proposed by Reclamation District 817 and a variance to the standard levee inspection trench width of twelve feet [23 CCR § 120(a)(9)(B)]. The Project will mitigate an ongoing erosion site, provide protection from under and through seepage, and add resiliency to the existing federal levee embankment. It consists of a 2,800-foot-long setback levee and cutoff wall along with a 7,500-foot-long landside levee buttress connected by a seepage berm. The Project is located on the north (right) bank of the Bear River within Unit 146 of the Sacramento River Flood Control Project about two miles west-southwest of the City of Wheatland in Sutter County.
