  - A. <u>Permit No. 19516 San Joaquin County Escalon-Bellota Road Bridge Replacement (Br. No. 29C-038)</u> (Jacqueline Hoang, Operations Branch, Board Staff)

Consider approval of Permit No. 19516 to remove the existing Escalon-Bellota Road Bridge (Br. No. 29C-038) and construct a new bridge over Littlejohns Creek. The bridge replacement project includes construction of new roadway approaches, installation of new guardrail system, construction of new bridge drainage system, installation of rock slope protection along the creek banks at the bridge abutments, construction of a temporary detour bridge east of the existing bridge, installation of a temporary creek diversion system/cofferdams upstream and downstream of the work area, installation of falsework to construct bridge deck, removing 13 trees and restoring riparian habitat, excavation of approximately 245 cubic yards of soil and 400 cubic yards of reinforced concrete from the creek channel. The new bridge will be approximately 135-foot long and 35-foot wide. The project is located 0.3 miles south of the State Route 4 and Escalon Bellota Road intersection in the town of Farmington. (San Joaquin County).

B. <u>Permit No. 19567 City of Sacramento – Del Rio Trail Project</u> (Nate Kibret, Operations Branch, Board Staff)

Consider approval of Permit No. 19567 to construct the Del Rio Class 1 multi-use trail that connects to the existing Sacramento River Bike Trail via 61.8 feet long, 14 feet wide cast-in-place reinforced concrete box approach structure. The approach structure cross section consists of 12 feet wide paved multi-use trail with 2 feet unpaved shoulders that will tie-in to the existing Sacramento River Bike Trail. The project is located where Southern Pacific Railroad Bridge crosses Interstate 5, approximately 0.3 miles north of the intersection of Sutterville Road and the left (east) bank levee of the Sacramento River, in the City of Sacramento. (Sacramento County).

C. Permit No. 19607 Tehama County – Evergreen Bridge Replacement (Br. No. 08C-0008) (Jacqueline Hoang, Operations Branch, Board Staff)

Consider approval of Permit No. 19607 to remove the existing Evergreen Bridge (Br. No. 08C-0008) and construct a new Bridge (Br. No. 08C0383) upstream (south) of the existing bridge within the South Fork Cottonwood Creek Designated Floodway. The bridge replacement project includes realigning Evergreen Road to match the new bridge, placing rock slope protection on the streambanks at new bridge abutments, installing temporary falsework to construct the new bridge, and hydroseeding and tree planting. The project is located approximately 0.3 miles northwest of the Evergreen Road and Bowman Road Intersection, and about 3.3 miles southwest of the Town of Cottonwood. (Tehama County).
