

Errata

DWR has identified several minor modifications to the published text of Addendum No. 1 to the 2012 Central Valley Flood Protection Plan (CVFPP) Program Environmental Impact Report (PEIR). None of the modifications change the conclusions of the document. Specific modifications are described below:

Section 5.2, Biological Resources - Terrestrial

This section identified several changes to Table 3.6-4 from the 2012 PEIR. Modifications to the table published in Addendum No. 1 include:

- Shasta salamander, black tern, and willow flycatcher are removed from the table on pages 10 and 11 and from bulleted introductory text on page 10. The listing status and habitat descriptions for these species are unchanged from the 2012 PEIR.
- Crotch bumblebee (*bombus crotchii*) is added to the table as a California species of special concern. Habitat for the crotch bumblebee is described as “Open grassland and scrub habitats. Typically nests underground or in grass, old bird nests, rock piles, cavities of dead trees.”
- DL (delisted) is removed from the list of status definitions at the bottom of Table 3.6-4.

At the bottom of page 12, the elderberry shrub survey radius is shown underlined as a change, to a radius of 165 feet. The previous survey radius (100 feet) should be shown in strikethrough text.

Section 5.4, Cultural and Historic Resources

Several instances of the word “Tribe” are shown as capitalized in this section without being marked as a change, although the original text in the 2017 Supplemental PEIR did not use a capital T. In accordance with DWR’s policy the word “Tribe” will be globally capitalized throughout the Cultural and Historic Resources chapter in the Consolidated PEIR being prepared by DWR to show the 2012 PEIR text as modified by the 2017 Supplemental PEIR and the 2022 Addendum No.1 to the PEIR.

Section 5.5, Cumulative Impacts
