A. <u>Permit No. 19216-4 United States Fish and Wildlife Service – Anadromous Fish</u> <u>Restoration Program</u> (*Nate Kibret, Operations Branch, Board Staff*)

Approval of Permit No. 19216-4 to construct phase four of the Hallwood Side Channel and Floodplain Restoration Project that includes – removing approximately 400,000 cubic yards of sediment from the Middle Training Wall and surrounding floodplains in the lower 1 mile of the project site; enhancing 21 acres of floodplain habitat that consist of grading work to lower the floodplain elevations; installing in-stream woody materials; and planting approximately 3 acres of riparian vegetation (Yuba County).

B. <u>Permit No. 19589 Union Pacific Railroad (UPPR) Bridge Replacement</u> (Humberto Negrete, Operations Branch, Board Staff)

Approval of Permit No. 19589 to replace an existing 13span, 286-foot-long timber stringer trestle ballast deck bridge spanning Dry Creek with an 11-span, 304-foot-long prestressed concrete box bridge. Two (2) temporary in-water causeways will be constructed for site access and construction activities. The project is located where the existing UPRR Valley Subdivision rail line spans Dry Creek at Milepost (MP) 129.52, approximately 1.5 miles northwest of the community of Wheatland (Yuba County).

C. <u>Permit No. 19680 California Department of Transportation</u> (Deb Biswas, Operations Branch, Board Staff)

Approval of Permit No. 19680 to authorize two existing bridges and retrofit bridge hinges with pipe seat extenders and cable restrainers under the bridge deck to provide additional support length to prevent the span from dropping, strengthening the

California Central Valley Flood Protection Board Meeting, December 16, 2022 overhang with Composite Fiber Polymer trips, replacing bridge rails and sidewalk, and replacing the existing polyester overlay from the top of bridge deck for both the right and left bridges (39-009 R/L) crossing Bear Creek. The proposed bridges (39-009 R/L) are located on State Route 59 crossing Bear Creek at Caltrans Post Mile 15.23 (Merced County).

D. <u>Permit No. 19690 Union Pacific Railroad (UPPR) Bridge Authorization and Repair</u> (Humberto Negrete, Operations Branch, Board Staff)

Approval of Permit No. 19690 to authorize an existing multi-segment, 25-span, 735foot-long, single-track railroad bridge spanning the Kern River Designated Floodway and to retrofit existing bents B10 and B11 within Segment B of the bridge, which consists of a 16-span, 480-foot-long deck plate girder-ballast deck structure located along the left (east) overflow bank of the river. The retrofit consists of eight (8) 10-inch diameter drilled shafts around the existing pier footing, with a driven 9-5/8-in diameter steel casing at the top 6 feet, and filling the shafts with grout. The micropiles will be embedded in a reinforced concrete ground collar surrounding the existing pier footing. A sacrificial micropile and a temporary rockfill causeway will be removed after construction. The project is located where the existing UPRR Fresno Subdivision rail line spans the Kern River at Milepost (MP) 310.35, approximately 2 miles northwest of the City of Bakersfield (Kern County).

E. <u>Application No. 19699</u>, Natomas Cross Canal Channel Enhancement and Levee Berm <u>Project</u>, <u>Reclamation District 1001</u>, <u>Statement of No Objection</u> (*Mike Zelazo, Flood System Improvement Branch, Board Staff*)

Approval of the second Statement of No Objection to be issued to the U.S. Army Corps of Engineers pursuant to 33 USC 408 affirming that the Board supports the proposed alteration to the Sacramento River Flood Control Project (SRFCP) at the Natomas Cross Canal in Sutter County and agrees to assume operation and maintenance responsibilities for the completed work as the non-federal sponsor of the SRFCP. Reclamation District 1001 proposes to lower the existing islands within the channel in order to provide additional habitat for aquatic species and construction of a levee berm/buttress using the excavated channel soil against the landside slope of the north levee (Sutter County).

F. <u>Permit No. 19703 County of Fresno Bridge and Box Culvert Replacement</u> (Jacqueline Hoang, Operations Branch, Board Staff)

Approval of Permit No. 19703 to remove and replace the existing bridge on Burrough Valley Rd and existing box culvert on Tollhouse Rd over Dry Creek/Dry Creek Tributary. The scope of work includes raising the elevation of the Burrough Valley Road/Tollhouse Road intersection, placing rock slope protection upstream and downstream of the bridge, excavation and pile drilling, roadway approach work on Burrough Valley Rd and Tollhouse Rd, installing temporary creek diversion and on-site detour, and constructing Type 836 concrete barriers (Fresno County).
