OPERATIONS BRANCH Status Report and Work Activities

General Branch Updates

Online Permitting Application

The Board received one-time funding in fiscal year 2022/2023 to develop an online permitting application, which will enable applicants to submit encroachment permit applications through an online portal. This will reduce permit processing time by the Board and increase transparency with applicants. A task order for the development of the online portal was approved on January 31, 2023, with a targeted completion date on January 31, 2024. In the last month, the consultant continued incorporating comments received from staff and continued coding the functions. A draft version of the portal is currently being tested by the Board staff.

Database Record Cleanup

Efforts continue in digitizing Board's encroachment permits and storing them in the Board's database (EP_Entry). These records supply information to the Encroachment Viewer, an application providing geographic context for information frequently needed by Board staff for case study and analysis. The more records are converted into digital format and uploaded to the database, the more valuable the Viewer can be. Of the total over 22,000 permits, about 726 have been converted into digital format, and staff has updated 6207 records in the permit database. In the month of July, branch staff scanned and updated records for 26 permits into the database. Hiring of youth aids has been delayed due to scheduling conflicts. Administrative staff is working to re-advertise.

Middle-Mile Broadband Network Project Permit Coordination

The Middle Mile Broadband Network project is seeking to install up to 10,000 miles of fiber optic Broadband infrastructure. Through discussions with Caltrans the project is estimated to have 180 encroachments which may require a Board action and of those possibly 50 actions to USACE section 408. Caltrans is still working on designs,

but a specific date of completion has not been provided. Board managers continued coordinating with the Middle-Mile Broadband Network Project team in the last month and are working on details of an interagency agreement (IAA) with California Department of Technology and California Department of Transportation. The IAA is now with DWR for legal review. In anticipation of the need for consultant support, staff finalized a task order, which will enable access to the Board's database to outside users (e.g., consultant).

Board Workshop on Operations Theme

Operations Branch managers hosted the Board Workshop on August 11, 2023, for the implementation of the Board's Resolution of Adoption No. 2022-29 for the 2022 Central Valley Flood Protection Plan Update that is related to the Operations Theme. Staff will review comments received from the workshop and start developing plans to achieve the goals and objectives identified in the workshop.

Enforcement Section

1. Staff News

Eric Miao has submitted his resignation and his last day with the Board will be August 31, 2023. Since 2016, Eric has been a critical section member, serving as Program Manager for the PL 84-99 program that includes coordination work for PL 84-99 rehabilitation repairs, Letters of Intent, and U.S. Army Corps of Engineers' Inspections. Section chief is working on a transition plan to minimize any disruptions to this program.

2. Board Enforcement Program

Staff continues to process encroachment cases by issuance of Notices to Comply (NTC) and Notices of Violation (NOV) as appropriate. Status below represents the activities that occurred as of July 2023:

3. Cease and Desist Order (CDO) Enforcement Case No. 2022-15450

Respondents have failed to comply with Board-adopted CDO. Enforcement hearing documents were issued on July 25, 2023 to Respondents. The hearing is scheduled for August 25, 2023 Board meeting as agenda item 10A.

4. Local Maintaining Agency (LMA) Coordination

Staff continues to coordinate with LMAs as more elect to participate in U.S. Army Corps of Engineers (USACE) System-Wide Improvement Framework (SWIF) program to regain eligibility for the federal Public Law (PL) 84-99 Program. A Letter of Intent (LOI) prepared by the LMA precedes the SWIF report. Because USACE evaluates federal levees by system, it is possible for multiple LMAs to participate in the SWIF program together if their levees are part of the same system.

LOI Report

- On July 27, 2023, MBK on behalf of RD 2062 and RD 2107, submitted an LOI for review and submission to USACE. Staff provided review comments and will be scheduling at September board meeting for official transfer to USACE.
- There are now 8 LOIs pending USACE review. The following table provides current status of pending LOIs at the different USACE review levels.

^{*} American River Flood Control District is currently active in PL 84-99 but has prepared a draft LOI in anticipation it will become inactive once USACE completes its final levee inspection report. USACE began inspecting this levee system in February 2023. Submission of LOI will occur in fall 2023, ahead of USACE' finalization of the inspection report.

5. PL 84-99 Rehabilitation Assistance Status

Staff continues to participate in bi-weekly PL 84-99 coordination calls with USACE, DWR, and LMA representatives to receive progress on flood damage repairs from 2019 storms.

2017 Flood Damage Repairs:

No updates.

2019 Flood Damage Repairs

Updates for the remaining four sites are as follows:

- USACE received real estate certification package from DWR on June 16 for two RD 108 sites and is certifying the documents prior to proceeding with repairs.
 We are anticipating this project to be awarded before the end of the calendar year and repair to occur in Spring 2024.
- No update from last month's report on the other two sites (MA 3 (now under LD1) and MA 5) as the USACE prioritizes real estate requirements in RD 108. USACE intends to begin the final designs and real estate packages for these two sites in Fall 2023.

2023 Flood Damage Repairs


On July 19, 2023, USACE issued a notice to open PL 84-99 Rehabilitation Assistance for the San Joaquin and Delta Basin. The notice was disseminated to LMAs on July 20, 2023. Submissions are due to USACE by Friday, August 18, 2023. As of August 14th, Board staff has received 42 sites from the San Joaquin and Delta Basin. Staff will transmit all requests received to USACE by August 18, 2023.

USACE is currently reviewing requests submitted for damages in the Sacramento River Basin. LMAs will be notified as more information becomes available.

6. PL 84-99 Levee System Status

The data and chart shown below include the most updated information about the PL 84-99 Status as of August 25, 2023.

- 56 systems (46.3 percent) are "inactive" including the 12 LSJLD systems. 8 of these systems are covered in draft LOIs as noted in the table in Item 4.
- 51 systems (42.1percent) are "active with LOI".
- 14 systems (11.6 percent) are "active without LOI". Nine (9) systems are "active without LOI" because the systems have successfully passed USACE re-inspection. And there are five (5) South Sacramento levee systems built by USACE.



Permitting Section

1. Staff News

The permitting section conducted interviews in August and has made one tentative offer to an applicant. The second position has been reposted for further consideration.

2. Outreach/Pre-Application

During the month of July, Permitting Section staff participated in 6 preapplication meetings and 9 project coordination meetings, along with USACE staff (where there is a federal interest) and Board's environmental staff. Inspection Section

1. Staff News

• The process to hire an inspection engineer is nearing completion, and the section is looking to welcome a new staff member in the coming month.

2. Inspection Program Updates

- A total of seventeen projects were assigned to inspectors from July 6, 2023 to August 15, 2023. They include seven pipe installation/replacement projects, two utility pole projects, one ramp installation project, one parking area improvement project, two slope repair projects, one boat dock project, two bridge replacement projects, and one silt removal project.
- Staff is looking to streamline the review and response process for Time Variance Requests it receives. On August 1, 2023 a brainstorming session was held and staff are currently developing documents to outline a strategy for improving the review process without sacrificing the regulatory requirements for oversight of any construction that permittee's request to conduct during the flood season.
- Below is a summary of inspection activities for the previous two months.
 - Inspectors visit sites for active construction, routine inspections, or in support of other Board programs. Construction activities have increased significantly now that weather has cleared and channel conditions have improved.
 - Construction Closeout Reports are used to track the final completion of a project. A project will be documented as complete if all permit conditions were met, and associated databases, levee logs, and other records are updated appropriately with inspection reports, as-builts, and other pertinent project information. Construction Closeout Reports also inform when the next routine inspections are due. For projects below noted as "being processed," the construction may be completed, but certain documents such as as-builts or compaction reports are still needed from the permittee, or a final review is still needed.

- One project submitted a Time Variance Request to continue work during the flood season in the San Joaquin River Basin, where the official flood season ends July 15. The request was approved.
- The Routine Encroachment Inspection Program is being developed by inspection staff. Notification letters are being drafted to inform permittees that are subject to routine inspections and associated fees when a routine inspection is planned for their encroachment to verify continued compliance with the permit conditions. Staff are actively working to develop a set of guidelines for conducting pipe inspections. This document will serve as a video inspection fact sheet for permittees to reference and gain an understanding of what is required for their routine inspection. In addition, routine inspection intervals are being re-assessed to align with USACE and Board priorities.

3. Coordination

- On July 26, 2023, the Inspection Section chief met with PG&E and DWR
 emergency preparedness staff to discuss the communication protocols each
 group uses for notifications of flood events. While the Board permits many of
 PG&E's facilities and emergency action requests, it is DWR's Flood
 Operations Center who is the main point of contact for immediate flood
 emergency response team. PG&E was given the correct contact information
 from both DWR and the Board for these situations.
- The monthly DWR / USACE / Board Coordination meeting was held on August 14, 2023. Topics included updates from DWR – Flood Project Inspection and Assessment Sections, DWR/USACE Programmatic Biological Assessments, Deferred Maintenance Project and Flood Maintenance Assistance Program, Storm Damage DWR Emergency Repair, and PL84-99 site rehabilitation statuses.
- The LMA-Board Workgroup (LBWG) small team met on to discuss potential updates to Title 23 regarding encroachment permits versus system improvement permits to better streamline the permitting process for each type of project. The large group will convene within the next month to go over the proposed language.
- Coordination continued with the Deferred Maintenance Project staff on proposed replacements and repair to system pipes eligible for rehabilitation under the program.

4. Automatic Board Order (ABO) Encroachment Reclassification Updates
