Approve permit 19727 authorizing the following features associated with Phase 1 of the Dry Creek Greenway East Trail (DCGET) Project: widening the existing Darling Way bridge where it spans Dry Creek; relocating an existing 12-inch diameter water main attached to the bridge; and constructing a new paved multi-use off-street trail with an undercrossing, access ramp, retaining walls, erosion control, and storm drains with outfalls along approximately 400-feet of the right (west) bank of Dry Creek. A temporary water diversion will be needed for construction (Placer County).

Approve permit 19728 authorizing the following features associated with Phase 1 of the Dry Creek Greenway East Trail (DCGET) Project: constructing a new 110-foot-long pedestrian steel bridge (Bridge No. 2) crossing Dry Creek with rock slope protection at the new bridge abutments; and constructing a new paved multi-use off-street trail with a trailhead facility, access ramps, erosion control, and storm drains with outfalls along approximately 300-feet of the right (west) bank of Dry Creek. A temporary water diversion will be needed for construction (Placer County).

C. <u>Permit 19729 City of Roseville Public Works</u> (Humberto Negrete, Operations Branch, Board Staff)

Approve permit 19729 authorizing the following features associated with Phase 1 of the Dry Creek Greenway East Trail (DCGET) Project: constructing a 155-foot-long pedestrian steel bridge (Bridge No. 4) crossing Cirby Creek with rock slope protection at the new bridge abutments; and constructing approximately one mile of a new paved multi-use off-street trail with retaining walls, riprap, undercrossing, and storm drains with outfalls along the left bank of Cirby Creek. Temporary water diversions will be needed for construction (Placer County).

D. <u>Permit 19730 City of Roseville Public Works</u> (Humberto Negrete, Operations Branch, Board Staff)

Approve permit 19730 authorizing the following features associated with Phase 1 of the Dry Creek Greenway East Trail (DCGET) Project: constructing an 80-foot-long pedestrian steel bridge (Bridge No. 14) crossing Linda Creek with rock slope protection at the new bridge abutments; and constructing approximately 1 mile of a new paved multi-use off-street trail with retaining walls, riprap, undercrossing, and storm drains with outfalls along the left and right banks of Linda Creek. Temporary water diversions will be needed for construction (Placer County).

E. <u>Permit No. 19445-4 City of Sacramento Water Forum</u> (*Jacqueline Hoang, Operations Branch, Board Staff*)

Approve Permit No. 19445-4 to perform habitat restoration activities as part of the Lower American River (LAR) Anadromous Fish Habitat Restoration Project - Upper River Bend Phase 1 site, previously authorized under Programmatic Letter of Permission 408-SPK-2022-0009. Project activities include excavating, sorting, grading, and placing materials on side channel and in channel; establishing temporary site access routes; placing 43 instream woody habitat structures; and planting 3.7 acres of shaded riverine aquatic vegetation (such as willows) along project margins. This project is located along approximately 0.9-mile stretch of the American River beginning approximately 4.2 miles downstream from the Sunrise Bridge crossing over the American River in Sacramento County, California (Sacramento County).

A. <u>Resolution No. 2023-06</u>, <u>Project Partnership Agreement, Sacramento River Bank Protection</u> <u>Project</u> (*Mike Zelazo, Flood System Improvement Branch, Board Staff*) (Action)

Adopt Resolution No. 2023-06, to approve the Project Partnership Agreement (PPA) between the federal government, represented by the U.S. Army Corps of Engineers, and the State of California, represented by the Central Valley Flood Protection Board, for the Sacramento River Bank Protection Project, Phase II supplemental authorization for an additional 80,000 feet of bank protection measures (Project). The PPA describes the Project and the responsibilities of the parties in cost-sharing and implementing the work, including design, construction, and long-term operation and maintenance. The Project is located along the Sacramento River Flood Control Project levee system from Solano County in the south up through Butte County and into Tehama County.

B. <u>Third Supplement to the Memorandum of Understanding Respecting the Sacramento River</u> <u>Flood Control Project</u> (*Mike Zelazo, Flood System Improvement Branch, Board Staff*) (Action)

Approve the Third Supplement to the Memorandum of Understanding (MOU) Respecting the Sacramento River Flood Control Project (SRFCP) due to the completion of the 200-Year Goldfields Levee Project (Project). The Project consists of a new levee embankment 2.6 miles in length, the degrade of 0.2 miles of the existing Yuba River left bank levee, and appurtenant system improvements. Federal authorization for the Project is provided by Section 1305 of the Water Resources Development Act of 2018, which requires the U.S. Army Corps of Engineers to amend the SRFCP MOU to reflect the modified levee length (Yuba County).

C. <u>Statement of No Objection, Sutter Butte Flood Control Agency, Tudor Flood Risk Reduction</u> <u>Project.</u> (Dustin Sanoski, Flood System Improvement Branch, Board Staff) (Information)

Approve the initial Statement of No Objection to the U.S. Army Corps of Engineers (USACE) pursuant to 33 USC 408 (Section 408) requesting that USACE evaluate the Section 408 request to alter levees of the Sacramento River Flood Control Project (SRFCP) in the vicinity of Nicolaus in Sutter County. Sutter Butte Flood Control Agency proposes to construct 8,800 linear feet of soil-bentonite cutoff wall on the west levee of the Feather River within Unit 143 of the SRFCP approximately sixteen miles south of Yuba City (Sutter County).
