4. BOARD ITEMS

The Board adopted the 2022 Central Valley Flood Protection Plan Update (Plan) through Resolution of Adoption 2022-29 (Resolution) on December 16, 2022. Through adoption of the Resolution, the Board identified known and achievable goals that will contribute to the goals of the Plan.

At the Board's June 9th, 2023 workshop, staff proposed five themes to categorize the Board's Resolution goals. The five themes are Implementation, Climate Resilience, Funding, Operations, and Strategic Planning. The October Workshop theme is Implementation, which includes eight Resolution goals. The October Workshop is focused on the Implementation goal of Modernizing the Board's Standards, with an emphasis on permitting and implementing flood system improvement, multi-benefit, and ecosystem restoration projects.
