## 1. ROLL CALL/ESTABLISH A QUORUM (Water Code § 8560)

Jonah Knapp, Board Clerk and Executive Assistant, called the roll and a quorum was established.

## 2. WELCOME, INTRODUCTIONS AND ANNOUNCEMENTS

Jane Dolan, Board President, welcomed the participants.

Chris Lief, Board Executive Officer, welcomed Travis Comstock, a new Staff Engineer in the Sacramento Levees Section.

## 3. REVIEW AGENDA

President Dolan briefly reviewed the agenda.

## 4. APPROVE MINUTES

The approval of the Minutes was postponed.

## 5. CONSENT ITEMS

## A. Approve Permit No. 19756, City of Chico Notre Dame Blvd. Bridge, Butte County

Upon motion by Board Member Countryman, seconded by Board Member Bosler, the Board unanimously approved, by a vote of 6-0, Consent Item 5A (Absent – Johnson).

## 6. PUBLIC COMMENTS

Brenda Gustin requested several things regarding the USACE American River Erosion Contract 3B: that a workshop be held specifically dedicated to the subject and expressed her hope that the workshop will be scheduled on the 2025 Board Calendar, and asked that we tell interested parties when that will be; that the Board request that USACE provide answers to the question of how many trees will be removed; that we request a USACE Engineering with Nature staff person be identified to work on the project; that we identify a liaison between our staff and the public; and that USACE utilize methods that control erosion and also meet other values.

Nancy Kniskern discussed the 2016 American River General Reevaluation Report Appendix that provided copies of the public comment letters received at that time and noted that many of those comments echo community responses just filed in 2024. She noted that area residents are now seeking time for meetings and workshops with other public agencies as they have not been able to engage in dialogue with USACE.

Tom Engler, MBK Engineers and on behalf of the California Central Valley Flood Control Association, discussed the Section 408 funding shortfall and the large backlog on that program and the Sacramento River Bank Protection Project.

Edward Smith commented on the erosion protection along the American River that is being implemented and proposed.

## 7. LEGISLATIVE UPDATE

A. A written update on pertinent State legislation and federal news will be provided.

President Dolan noted that the Board did receive the written update.

## 8. UNITED STATES ARMY CORPS OF ENGINEERS (USACE)

#### 9. BOARD ITEMS

## A. Approve Permit No. 19712, Union Pacific Railroad Butte Creek Bridge Replacement, Butte County

Celina Ortega, Board Staff Engineer, Operations Branch, gave the presentation, answered questions and stated the Board staff recommendation that the Board adopt the CEQA findings; approve the variances to Board standards 128(a)(3) and 128(a)(16), as provided in the staff report; and lastly, direct the Executive Officer to file a Notice of Exemption with the State Clearinghouse.

Steve Lamb, Board Permitting Section Manager, provided additional information.

Board Member Andrews suggested amending the permit to include language that requires UPRR to incorporate language reflective of the permit condition into the Emergency Action Plan.

Upon motion by Board Member Griego, seconded by Board Member Bosler, the Board unanimously approved Permit No. 19712, including the amendment suggested above.

# B. Presentation of the USACE System-Wide Improvement Framework (SWIF) program

Zubair Dosu, Board Deferred Encroachment Compliance Section Manager, introduced the item and presented the SWIF metrics relevant to the Board as the non-federal sponsor.

Stephen Vithalani, USACE Sacramento District Emergency Management Office Public Law 84-99 Program Manager, provided a detailed summary of the program.

Tom Engler, MBK Engineers, discussed the Flood System Repair Program and answered questions.

Meegan Nagy, Sacramento River West Side Levee District and Reclamation District 108, added clarifying information.

Board Members commented on various parts of the presentations.

## C. Presentation of the Board's Calendar for 2025

Executive Officer Lief presented the draft 2025 Board Calendar.

Board member Bosler requested that staff also put together a calendar, to the extent they are able, of other important water meetings, conferences, and events that will occur.

Board Member Countryman expressed impatience regarding a lack of feedback to the Board and the public about the questions that have been raised regarding the American River USACE Contract 3B, recognizing that certain responses may have to wait for the official response to comments but that other answers might be provided more quickly.

Secretary Johnson agreed that many of the questions raised by the public could be answered more quickly, expressed a hope that they can be, and said that he would welcome a workshop in the field.

In response to a question from Board Member Countryman, Permitting Section Manager Lamb gave an overview of the status of various permits that are currently in the permitting process, and noted that due to staff turnover and vacant positions, the backlog has grown as roughly three permits have come in for every two that have been issued. However, they are issuing permits on a similar pace as recent years including more than 10 per month that are issued by the Executive Officer so do not need to come before the Board.

Board Member Countryman also requested information from USACE about their permitting timelines, and President Dolan suggested that they ask for a report from USACE in a future board meeting.
