# 1. ROLL CALL/ESTABLISH A QUORUM (Water Code § 8560)

Jonah Knapp, Board Clerk and Executive Assistant, called the roll and a quorum was established.

# 2. WELCOME, INTRODUCTIONS AND ANNOUNCEMENTS

Jane Dolan, Board President, welcomed the participants.

Chris Lief, Board Executive Officer, introduced Agustin Ortega, newest member of the Board Enforcement Section.

#### 3. REVIEW AGENDA

President Dolan briefly reviewed the agenda and announced that Item 9A would be an informational, rather than an action item.

# 4. APPROVE MINUTES – February 28, 2025

Upon **motion** by Secretary Johnson, seconded by Board Member Griego, the Board unanimously approved the February 28, 2025 Board Meeting Minutes.

Upon **motion** by Board Member Countryman, seconded by Board Member Griego, the Board unanimously approved Consent Items 5A and 5B.

# 6. PUBLIC COMMENTS

Pete Spaulding, American River Trees, offered two examples from other cities that might help change USACE in California.

Dirk Ruthrauff offered alternatives to Contract 3B on the Lower American River and asked for reassurances that a different approach has been or will be considered for 3B.

Daphne Dixon commented that the current Contract 3B approach seems antiquated. Further, she stressed that community engagement - two-way communication - was needed instead of community outreach, which is only one way.

Adam Borchard, California Central Valley Flood Control Association Executive Director, commented on Section 408 delays with USACE, which has received only sporadic, month-to-month funding. He also thanked Board staff for sending out a congressional funding request to U.S. Senators Padilla and Schiff for the Sac Bank Program; his association will be sending additional support letters.

Nancy Kniskern referenced a recent Scientific American article entitled "The Nation's Chief Engineers Turn to Nature to Improve Flood Protection. Will this enlightened approach prevail?" as a viable approach and reiterated her request that the Board not approve CEQA compliance when there are so many environmental solutions currently available that are more suitable and have not yet been considered.

Dominick Gulli provided an update on the Smith Canal Gate Project.

## 7. LEGISLATIVE UPDATE

# 8. UNITED STATES ARMY CORPS OF ENGINEERS (USACE)

A. Presentation of the USACE Levee Inspection Results for Reclamation District (RD) 1001 – Nicolaus, Feather River Levee System, Sutter and Placer County.

Jeremiah Peek, Board Staff Engineer, Deferred Encroachment Compliance Section and Juan Gonzalez, USACE, gave the presentation and answered questions.

Tom Engler, MBK Engineers and Zubair Dosu, Board Deferred Encroachment Compliance Section Manager, offered additional perspective and clarification.

## 9. BOARD ITEMS

# A. Informational item on the use of the "breach analysis" methodology to develop the boundaries of State Maintenance Area (MA) 20.

Michael Zelazo, Board Senior Engineer, Flood System Improvement Branch, introduced the item and provided Board staff's presentation.

Patrick Meagher, Reclamation District 784, discussed his district's efforts to continue maintenance in the area.

Tom Engler, MBK Engineers and on behalf of RD 817, provided additional information on funding shortages.

Brian Manning, Desmond Law Firm, representing Michael and Patricia Rue, gave a refresher on some of the history of the Sacramento River Flood Control Project and noted that the Board should be looking at the situation from a perspective that incorporates that history.

Stuart Hanson, Shady Oaks Ranch and speaking on behalf of his partners as well as David and Becky Gibb, fellow property owners in the area, offered additional perspective not available in the Board staff report.

Ralph Nevis, representing Shady Oaks Ranch and David and Becky Gibb, requested that the Board direct its staff to engage with them and determine who truly benefits from the proposed maintenance area, and to do so with an eye towards fairness instead of advocacy for their preferred position.

Board Members commented on various aspects of the analyses presented, considered potential solutions, and asked further clarifying questions. They provided additional history and asked the objecting landowners for more clarity about the alternative they would like the Board to pursue.

# B. Update on the upcoming release of the Public Draft of the Yolo Bypass Cache Slough Master Plan.

Kristyne Van Skike, Flood Planning and Programs Branch Program Manager and Mary Jimenez, DWR Systemwide Multi-Benefit Initiatives Branch Chief, provided the update and answered questions.

The purpose of the Master Plan is to guide continued project planning and implementation in this region consistent with the Central Valley Flood Protection Plan and its Conservation Strategy, and to inform the Yolo Bypass Comprehensive Study and Yolo Bypass Cache Slough Partnership. They confirmed that the Master Plan will not require a CEQA action.
