Applicant: South Sutter Water District

Location Description: The project is located along the Bear River Diversion Pool, approximately 5.5 miles northeast of the City of Wheatland and approximately one mile southwest of the Camp Far West Dam.

County: Placer

Stream: Bear River

Project Description: To authorize the existing Main Canal structure along with the three Rubicom

SlipMeters and SCADA equipment that replaced the Main Canal headgate.

LMA Endorsement: N/A

CEQA Finding: The project is exempt from CEQA under the Class 1, Existing Facilities categorical exemption (CEQA California Code of Regulations, Title 14, Section 15301), because the activity consists of the operation, repair, maintenance, permitting, leasing, licensing or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use. No expansion of existing or former use will occur. Further, none of the exceptions to the exemption in CEQA California Code of Regulations, Title 14, Section 15300.2 apply.

Applicant: City of Stockton Department of Public Works

Location Description: The project is predominantly located in-channel of Mormon Slough and spans approximately 1,400 feet upstream and 400 feet downstream of Wilson Way Bridge in Stockton, California.

County: San Joaquin

Stream: Mormon Slough

Project Description: To replace approximately 2,080 feet of existing 24-inch reinforced concrete sanitary sewer pipe with 30-inch polyvinyl chloride (PVC) sewer pipe, install three 10-inch PVC sewer pipes from the mainline to existing manholes, install 8 sanitary sewer manholes, remove portions of existing pipes and 5 manholes, and abandon-in-place and grout or remove and backfill sections of the existing 24-inch pipes. Most construction will be open trench with two sections of sewer line installed

by jack and bore. Temporary sewer bypass systems and erosion control measures will be used during construction.

LMA Endorsement: San Joaquin County Flood Control and Water Conservation District

CEQA Finding: As a responsible agency under CEQA, Board staff has reviewed the Mormon Slough Sanitary Sewer Line Replacement Project Draft and the Final Initial Study/Mitigated Negative Declaration (IS/MND) (State Clearinghouse No. 2023010192, approved on October 17, 2023), and the Mitigation Monitoring and Reporting Program (MMRP), prepared by the lead agency, City of Stockton. The proposed project is covered by the IS/MND. The City of Stockton determined that the project will not have a significant effect on the environment and filed a Notice of Determination with the State Clearinghouse on August 25, 2025 and the San Joaquin County Clerk on January 23, 2024. The City of Stockton incorporated mandatory mitigation measures into the project plans to avoid or mitigate impacts. These mitigation measures, included in the City of Stockton's IS/MND and MMRP, address impacts to biological resources, cultural resources, geology and soils, hazards and hazardous materials, hydrology and water quality (non-flood related), noise, Tribal cultural resources, and utilities and service systems. These mitigation measures are within the responsibility and jurisdiction of the City of Stockton and have been adopted by the City of Stockton. The IS/MND found no impact under hydrology for flood-related impacts associated with the proposed project.

In accordance with CEQA California Code of Regulations, Title 14, Section 15096(f), Board staff considered the City of Stockton's IS/MND, which supports the Board's approval of Permit No. 20035 to authorize work to replace sanitary sewer pipe which is within the Board's jurisdiction as it relates to effects on the federal-State facilities of the State Plan of Flood Control, regulated streams, designated floodways, and easements (Adopted Plan of Flood Control). The Board, as a responsible agency, is responsible for mitigating or avoiding only the direct or indirect environmental effects of those parts of the project which it decides to approve (CEQA California Code of Regulations, Title 14, Section 15096(g); Public Resources Code § 21002.1(d)). Here, the Executive Officer's action is limited to approving an encroachment permit, and the Board's jurisdiction is limited to imposing conditions to mitigate or avoid impacts to the environment under its authority, specifically the Adopted Plan of Flood Control.

According to the discussion within the IS/MND, the proposed project results in no impacts related to flood risk. When considering the record as a whole, and in accordance with CEQA California Code of Regulations, Title 14, Section 15096(f) and (g), staff recommends that the Executive Officer make responsible agency findings that approval of Permit No. 20035 will not result in any significant adverse impacts related to flood risk. The project will not adversely impact the Adopted Plan of Flood Control; therefore, no conditions or mitigation measures within the Board's jurisdiction are required.

District 1000 Unit No. 01 Sacramento River levee at levee mile 9.00.

County: Sacramento

Stream: Sacramento River

Project Description: This is a "name change" permit that includes conditions that are consistent with current flood control standards and policies of the Central Valley Flood Protection Board. This permit supplements and where in conflict supersedes Permit No. 3777 that was issued to Joe R. Yockers on September 21, 1961, to authorize the construction of a Dwelling.

LMA Endorsement: Reclamation District 1000

CEQA Finding: The Board has determined that an application to change the name of the permittee does not have the potential to result in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment, and thus, is not a "project" for purposes of the California Environmental Quality Act (CEQA Public Resources Code Section 21065; CEQA California Code of Regulations, Title 14, Section 15378(a)).
